Thoralby Moss - The Parish Council has advised the Rural Payments Agency (RPA) via the Land Agent WBW that the land is not currently being grazed. The RPA have come back with some questions and the Parish Council has confirmed that the land can and always has been accessible and the Parish Council as the DEFRA agreement holder and landowner still has management control and is still able to do all other management e.g. access with vehicles and equipment.

- Parking Signage at Village Hall not a Parish Council matter
- Bishopdale Bridge District Cllr Peacock has reassured on a number of occasions that this will be in the capital budget soon

## 11. BT Telephone Box, Aysgarth

The Parish Council discussed the Notice which had been displayed in the BT Telephone box on 28.01.25 and the importance of retaining the telephone box. Action - Clerk to write to BT at customer.serv.payphones@bt.com objecting to the removal of the Telephone Box on the following grounds and requesting restoration of the telephone box:

- The village has limited mobile phone signal at times and the BT Telephone Box therefore provides a lifeline to a rural community
- The village experiences a number of power cuts during inclement weather conditions
- A defibrillator is located on the outside wall of the Village Institute (a few yards away from the BT Telephone Box). The Institute does not have phone facilities, so the BT Telephone Box is a vital means of calling 999 to obtain the access code for the defibrillator
- The BT Telephone Box is cultural heritage in the village. It has been part of the village for decades
- The Parish Council has received a number of objections from local residents re the BT Telephone Box being removed

## 12. Grass Cutting 2025

The Parish Council considered the quote received from Mark Cooper to continue to cut the grass in Aysgarth, Thoralby & Thornton Rust villages at no increase in the rate of cut from 2024. The Parish Council welcomed the price freeze. Action - Clerk to accept quote in writing.
