### Minutes of the Meeting of the Parish Council held on 22nd June 2023 At Aysgarth Institute at 7.30pm

- 1. Consideration of Apologies for Absence Apologies were given and accepted from Parish Councillor Windle.
- 2. Minutes of Parish Council meeting held on The minutes of Meeting held on 25th May 2023 were approved as a true and correct record

#### Parking, Aysgarth

Aysgarth resident Steven Reynolds was welcomed to the meeting. He reported parking problems in the layby opposite Hamilton's Tea Rooms. People were parking without thought for others, spreading out and not using the space to its full capacity. The Parish Council agreed to contact Highways to ask if the layby could have bays marked out with white lines (including the area at the end) to maximise the use of space. Action - Clerk to contact Area 1.

Cllr Walker also raised the issue of occupants of the holiday let East Stonelea, Aysgarth parking on the village green outside the property. Action - Clerk to write letter requesting that they cease parking on the village green.

#### R/51/146 - Aysgarth Methodist Chapel, Chapel Lane, Aysgarth, DL8 3AE

Full planning permission for change of use of no more than 30% of the gross internal floor area to be used as accommodation for caretakers, artisans and exhibitors involved in the primary community use in the remainder of the property. This involves the change of use of elements of the building from class F1 to class C3 at Aysgarth Methodist Chapel. Amended Information - Rebuffal Summary, Heritage Statement and Parking Plan submitted by Applicant on 20.06.23.

The Parish Council had again been contacted by a number of residents expressing serious concerns. The Parish Council considered the Rebuffal Summary, Heritage Statement and Parking Plan. The Parish Council decided to reaffirm the **strong objection** submitted by the Parish Council on the 16.04.23 on the grounds of ongoing concerns regarding a religious building of historic importance being developed for residential use, car parking, access for residents to their properties & access for emergency vehicles and noise & disturbance.

#### Action - The Clerk was asked to report the following matters to Highways:

- A car has been damaged at the top of Mill Lane, Aysgarth. Clerk to chase up previously agreed works.
- The Parish Council queried whether Area 1 were planning to come back to Church Bank, Aysgarth, as although some works had taken place the road was still in a poor condition.

**Bins, Thoralby & Aysgarth** - Cllr Cooper reported that Thoralby village were still waiting for the bin which had been ordered over a year ago (and chased by the Clerk). Cllr Walker reported that Aysgarth could benefit from an additional bin suitable for dog waste to be situated near the garage in Aysgarth. The clerk advised that the Parish Council should wait until the year end out turn of the accounts before ordering an additional bin for Aysgarth. Cllr Peacock said that she would be able to help with the cost of both bins.
